Submit this form along with the manuscript.

For manuscripts not accepted for publication, this copyright will become null and void.

Use Part A: Copyright Transfer for:

1. Work Made for Hire (for company or government contract):

Use Part A if you are an employee of a company or institution and your paper was prepared as part of your job. This means that the copyright of the paper belongs to your employer. If you, as author, sign this copyright form, MRS assumes that you are authorized by your employer to do so and that your employer has consented to all the terms and conditions of this form. If you are not authorized to transfer copyright of this paper, this form should be signed by someone so authorized.

If you are an employee of a company or institution and your paper was prepared as part of a government contract with that company or institution, it also is a work made for hire. You or another authorized individual from your company should sign Part A of this copyright form and check the appropriate box.
